The Prospective Purchaser may cancel this reservation at any time (prior to an agreement for sale and purchase being entered into) by written notice to Bayleys in which case the Reservation Deposit shall be refunded to the Prospective Purchaser (without interest and less any bank charges, if applicable).3.
